



From the Congress restricted area you can download:

- Confirmation letter with the barcode, necessary to print the badge onsite at the "Badge print and Bag distribution" desk located in the Registration area of the Hungexpo in Budapest.
- Receipt of payment.
- Request of payment (if the payment is made by bank transfer).
- Certificate of attendance. IMPORTANT! ONLY the days in which you have actively scanned your badge will be printed in the certificate of attendance.
- UEMS certificate.
- Feedback Questionnaire.

All of the above documents must be printed from the Congress restricted area: it will NOT be possible to print them on site at Hungexpo in Budapest.

NEW CEPD! If you already registered and paid for the CEPD courses that will be held on June 13, you can choose/change for a maximum of 2 courses directly from the Congress restricted area <http://www.registration.era-edta2019.org/ra> within June 7.

If you have already booked the CEPD courses during the online procedure (and do not need to change them), then please disregard the above paragraph. Please notice that after June 7, 2019 it will NOT be possible to change the courses that you have chosen.

Please note that if the registration has been made by a third party, he/she can choose/change the CEPD courses on your behalf, still within June 7, 2019.

After June 7, 2019, CEPD booking will be closed and any changes should be made directly onsite at ?CEPD? desk at Hungexpo in Budapest by paying EUR 20.00.

Note also that once the CEPD badge is printed, if you decide to change the CEPD already chosen, there is a fee of EUR 20.00 to be paid at ?CEPD? desk at the Hungexpo.

Should you decide to attend the CEPD courses at a later stage, you can book and pay the due amount (only by credit card) directly from your Congress restricted area within June 13.

Note that the availability of the CEPD courses is on a first-come first served basis.
